1952 thru 2015  
( Current existing Contamination and Health concerns @ RF plant site.)

At the January 26, 2015 Rocky Flats Stewardship Council meeting, (Public Comment Period), I expressed that the Well Sampling for Plutonium and Radiological Contamination has been the main focus of Legacy Management and the Colorado Department of health CDPHE, I also repeatedly asked have any comparable (Soil Samples) for the entire plant site for all of the other Toxic and Hazardous Materials deposited on the plant site been taken, **(Please Note)**, my question was not answered.

After the closing of the Rocky Flats Plant site in 2005, the entire acreage area was designated to be managed by the USFWS, as a Wildlife Refuge area.

In the past and to date since the closing of the plant site, a diligent effort to change commitments and policies on the management and use of the Rocky Flats Site has been attempted, this has not been in the best interest or health of the citizens and communities in the State of Colorado.

The plant site still contains an enormous amount of Radiological, Hazardous and Toxic Material Contamination remaining (On and Below) the soil surface, and will continue decaying and contaminating the plant site and communities until removed.

**(Please Note): Inadequate and unacceptable cleanup of the Rocky Flats Plant site include Some of the following of many factors involved during the Cleanup and Final Closure of the RF Plant Site 2005.**

- a. **Imploding:** Contaminated Building structures, instead of removing & send to waste sites.
- b. **Capping:** Contaminated soil areas instead of removing & replacing the soil.
- c. **Conducting Tours:** Plant Site touring is not the best interest anyone's health, Expressly Individuals or groups that are disseminating incorrect information, in an effort to educate Students or any other citizen that Rocky Flats is safe: Rocky Flats is a contaminated dump site and will remain in the same condition for future generations.

Historical records of known areas of Spraying, Dumping, Burying and imploding the contaminated Buildings prior to and during the 2005 decommissioning period,of Toxic and Hazardous Chemicals and Materials that were used and identified in the FINAL DRAFT REPORT 3 & 4 (published) by, (Chem Risk 1992) for the State of Colorado Department of Health (CDPHE) describing the (historical records) (and estimated releases) of Toxic and Hazardous Materials that have occurred throughout the history Rocky Flats Plant Site.

Current and future use of this land is speculated to have been on the Drawing Boards for several years prior to the Closing of the Rocky Flats Facility, and now it is being encroached upon with the Candelas residential construction of new homes and other attempts to change the use of the wildlife refuge area, and perimeters of the plant site.
