Round Robin and Goals for Retreat

Sam Dixion – wants the Coalition to issue more statements and make a public stance on positions, work on water quality protection, long-term stewardship and final cleanup levels. Suggested round robin at end of meeting instead of beginning.

Mary Harlow - wants vision of end-state to guide decisions.

Tom Brunner – wants to be on forefront of issues and work with ECA on policy issues to lobby in Washington DC.

Hank Stovall – wants to set priorities on issues like D&D, cleanup levels, worker safety. Work with Congressional delegation. Urged members to attend RFCA Focus Group meetings.

Paul Danish – wants to pass Allard-Udall bill and maintain integrity of bill, don't let land use creep into it.

Closure and Allard-Udall Bill

Arvada - Ken Fellman:

- Open space with limited public access (ex-trails)
- Small portion close in proximity for transportation corridor, subject to clean property
- No large, overbearing fences that give a bad impression

Superior – Andrew Muckle

- No imposing fences
- Minimal amount of engineered barriers

City of Boulder – Lisa Morzel and Amy Mueller

• Quick passage of Allard-Udall bill with current language

Westminster – Sam Dixion

- Pass Allard-Udall bill in current form
- Protect water quality
- Minimize caps and restricted areas
- Minimize institutional controls and engineered controls (thus reduced monitoring)
- Keep ponds they work well for settling contaminants
- Use appropriate wildlife fencing with low visibility (ex- split rail or mesh)

Broomfield – Tom Brunner

- Minimize structures left in place, including foundations
- Keep property open for greater good
- Support a transportation corridor as it will be necessary

Hank Stovall

- Protect water quality, including maintaining 0.15 pCi/L, ponds work well
- Minimize engineered barriers
- Support transportation corridor of 150' easement
- Support Allard-Udall bill w/ protection of water rights
- Support unobtrusive perimeter barrier
- Support public access for wildlife viewing may need interior fencing
- Minimize restricted uses

Boulder County – Paul Danish

- Site truly be closed
- Passage of Allard-Udall bill, continuing wildlife habitat
- No roads to break up refuge
- Public access would be incompatible with the refuge and cleanup uncertainties
- Fence/barrier would be necessary, can be unobtrusive (ex-barbed wire)
- Do not reopen to any government uses

• Prioritize cleanup (ex-water quality, then air quality...remember other hazardous materials)

Jefferson County – Michelle Lawrence

- Protect surface water quality from all contaminants
- Support Allard-Udall bill
- Keep transportation options open (widen Indiana if necessary) and let process (ex-NEPA) work when appropriate
- Support public process for wildlife management
- Urge highest cleanup within reason
- Advocate worker and citizen safety
- Support attractive, but strong, fence
- Advocate public access if practical and feasible

David Abelson went over the following areas of agreement:

- Minimize controls (although there will be some necessary).
- ie-minimize contamination, and controls so that if the controls fail the risk faced will be less.
- Support Allard-Udall bill
- ➢ Refine water rights
- Define transportation corridor
- Support best cleanup possible minimize restricted areas
- Support unobtrusive fences
- Ensure water quality protection
- ➤ How? ie ponds, engineered barriers

The group agreed the following would need to be addressed:

- Foundations/infrastructure left in place and subsurface contamination
- Mineral rights and other natural resource rights
- Minimal radioactive footprint
- Post-closure contingency planning (as part of long-term stewardship)

Steps forward:

- Address long-term water quality protection and devise a position the Board can promote
- Allard-Udall bill: decide on water rights language (Broomfield) and transportation corridor option (150' vs. 300' and Indiana vs. Section 13)
- > David and staff research and provide Board transportation corridor information
- Decide on issue at January meeting

Workforce Issues

The Board listed the following suggestions as worker issues that should be addressed:

• Good worker retention

- Worker morale
- Consensus on issues for the lobbying trip
- Health benefits for all workers
- Early retirement packages
- Early retirement language
- Incentives to help/work towards closure
- Worker transition
- Worker safety
- Research Kaiser-Hill performance bonus and workforce restructuring
- Work with DOE, Congress, etc. to bridge benefits appropriately (review feasibility)

Steps forward:

- David and staff research and present worker information at future meeting
- Reign-in issues and narrow focus

Coalition Process Issues

The Board suggested the following process procedures:

- Move Round Robin to the end of the Board meeting
- Directing staff projects:
- > If four groups want to discuss/work on an issue, appropriate to move forward
- Consensus vs. majority
- > If a minority, a limited amount of time should be spent
- Avoid duplication of staff work
- Add staff/Coalition recommendations to the Board Consent Agenda
- Trust the staff to do their job
